## **Part One: Purpose**

Our commitment to environmentally conscious action is included in the MJ Code of Conduct. This Environmental Policy stipulates the objectives that form the basis of our conduct and the specific actions we will take to achieve them. This policy has been established through a resolution of the Board of Directors and applies to all MJ group.

## Part Two: Our approach to addressing environmental issues

Environmental issues are becoming more diverse and complex, and are recognized as one of the most pressing global concerns.

Our economy, industries and society are supported by the varied benefits received from natural capital 1 and ecosystems. We believe that addressing environmental issues which impact such resources is humanity's shared responsibility towards a sustainable society.

At MJ, we recognize that our business activities may have both a direct and indirect impact upon the environment. We also believe that environmental initiatives such as mitigating and adapting to the impact of climate change, preserving biodiversity, and promoting circular economy are essential preconditions for the existence and activities of our company.

While maintaining a global and long—term perspective of risks and opportunities, we are aiming to enhance our corporate value and contribute to the creation of a sustainable society. We intend to achieve this by proactively implementing environmental initiatives which draw on our capabilities and knowledge of our group.

### **Part Three: Measures**

We expect every employee and contractor to adhere to this policy and help reach our goals by:

- Continually and effectively improving our environmental performance;
- Complying with and surpassing standards required by the applicable environmental ordinances;
- Fulfilling all environmental requirements prescribed by the Company;
- Promoting sound environmental policies and practices within the Company;
- Setting and reviewing environmental objectives;
- Conserving resources and maximising energy efficiency;
- Minimising waste wherever practicable;
- Reusing or recycling waste where appropriate and regulating the treatment and disposal of residual waste;
- Reducing and preventing pollution where possible;

- Enhancing environmental awareness of colleagues and contractors;
- Advocating good environmental practices on both departmental and individual levels; and
